

Subj: Letter to Grant Applicants, 2019 Grants Applications Availability

Dear Arts Organization:

**Funding Arts Broward's** mission is to enrich the Broward County arts community by funding Broward County-based visual and performing arts programs that meet eligibility requirements and present high quality programs to the public.

Applications for **Funding Arts Broward (FAB!) 2019 Grants** will be online as of Tuesday, October 10th, 2017 at [www.fundingartsbroward.org](http://www.fundingartsbroward.org) , see Grants section. The deadline for FAB! 2019 Grant Applications is **Tuesday, January 9th, 2018 at midnight.**

Organizations headquartered in Miami-Dade, Broward, and Palm Beach County are **eligible** to apply if,

- 1.) Grant Applicant has at least one active voting Board Member who either lives or works full-time in Broward County;
- 2.) All funded programs must take place in Broward County.

**FAB! 2019 Grants** will be awarded in amounts of no less than \$5,000. The maximum grant award for organizations with budgets under \$1 million will be \$10,000, and \$15,000 for organizations with budgets over \$1 million.

**FAB! 2019 Grants** are project-oriented, so applicants are asked to describe, in detail, the specific project, program, or program series for which they are applying for funding. **FAB!** will only consider entire seasons for funding, when the entire season is a cohesive series of programs.

- Applications will be considered based on your organizations compliance with the **FAB! 2019 Grant** Application Instruction Booklet, found on our website

- Late submissions will not be considered.
